
Tender Notice

Hiring of Vehicles (CNG fuel)

1. Sealed tenders are invited under **Two Bid System** i.e. (**Part-I Technical Bid and Part-II Financial Bid**) from reputed, experienced and financially sound Taxi service providers to provide rental CNG-fuel taxis to Prime Minister's Office, South Block, New Delhi. The contract will be initially for a period of two years which may be extended further for a period of another six months on review of performance depending upon the requirement and administrative convenience of Prime Minister's Office. The quantum of requirement of vehicles is tentatively 15 on a regular basis which may increase or decrease depending on the requirements of this Office.
2. **The tender document can be downloaded from the website of Prime Minister's Office pmindia.nic.in or pmindia.gov.in**
3. The **tender document complete in all respects alongwith Earnest Money Deposit(EMD)** of Rs. 2,00,000/- (Rupees Two lakh only) refundable without interest, in the form of Demand Draft/Pay Order drawn in favour of Section Officer, Prime Minister's Office, New Delhi may be **submitted by 5.30 PM on 01.06.2015 at the Dak Counter of Prime Minister's Office, South Block, New Delhi.** No tenders will be accepted after the stipulated date and time under any circumstances what so ever.
4. **The Technical Bid shall be opened on 04.06.2015 at 1500 hours** in Room No. 236D, Prime Minister's Office, South Block, New Delhi-110 011 in the presence of the representatives of firms who wish to be present. Only one representative of each firms would be allowed. At the first instance the technical bids shall be evaluated by a Tender Evaluation Committee (TEC) constituted for the purpose by the Prime Minister's Office. At the second stage financial bids of only those firms who qualify in the technical bid stage shall be opened at a later date. The scheduled time, date and venue for opening the financial bids will be communicated

separately. The Tender Evaluation Committee (TEC) shall, after evaluation of the Technical/Financial bids, give its specific recommendations regarding the lowest responsive bid, which is to be selected alongwith a comparison statement duly signed by the members of TEC.

5. The Competent Authority, Prime Minister's Office, reserves the right to cancel the tender at any time or amend/withdraw any of the terms and conditions contained in the Tender Document without assigning any reason, therefore.
