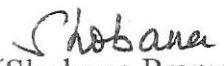
2. It is observed that you made an RTI application dated 24.08.2025 (Online No. 03120), seeking information relating to an earlier grievance.

2. It is observed that you made an RTI application dated 16.07.2025 (Received on 28.07.2025).

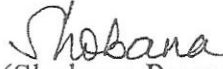
3. The CPIO, PMO, vide letter dated 08.08.2025 provided response of this office.

3. The CPIO, PMO, vide online response dated 12.09.2025, provided you response of this office.

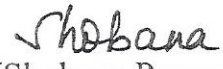
4. I have examined the matter and it is held that information provided in respect of your RTI application suffice as it is as per records of this office.

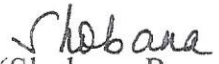
